Report from PLEBS – August 2005

The next AGM has been announced (28 Aug. 2005, 3pm). It looks like this could be a decisive moment in PLEBS history. The membership has dropped below 50 now, which is the number some believe is the minimum for a viable exchange. It is expected that some major policy changes might be adopted, one proposed course of action being the winding down of PLEBS. There are also 5 committee members and 2 trustees to be elected.

Taking advantage of Pete North's visit to New Zealand, PLEBS had an informal gathering with him to discuss issues regarding the future of the exchange. More than 20% of the membership attended and there seems to be a undercurrent of optimism that with considerable changes PLEBS might be able to blossom again.

At a recent market, the 2 millionth P\$ was traded and in a little ceremony the people involved acknowledged this. A picture and an article made it into one of the local papers.

Future tentative market dates are: 28 Aug, 14 Sep, 12 Oct, 9 Nov and 14 Dec 2005.

New Software

As requested at the recent Conference the Committee has evaluated online systems to handle transactions and Goods and Skills. The first system, Cyclos, was Dutch based and seemed to be a recent development and still had some way to go. We then checked out the South African Community Exchange System (CES), a system which has been operating in that area for some time. Although it is still under development it seemed to be working very well and had most of the features that we required and any additional requirements that we

wanted, could and have, been added. So the decision was taken to use it. All LCNZ members have been installed on it and the first trade has gone through. At the same time TATS agreed to change and from the beginning of August all transactions have been processed on the new System, some by the members concerned and the rest by the Transaction Recorder. It is very easy and user friendly to use. To date the feedback from TATS members has been very positive.

At least two other Groups Taranaki and WINGS are in the process of setting up and the Software is on offer to all LCNZ member Groups. The cost is nil, all that is required is a computer with a Browser (I recommend Mozilla Firefox not Internet Explorer) and an internet connection.

The amount of work involved in the change over will vary according to the size of your system but it is well worth while. The statistics the system provides are impressive and will give Managements much greater control over the health of their System.

This is the basis of a National System, that still allows local Groups to maintain their autonomy and continue to operate in their own way, it will allow Intertrading in a much simpler way than the old System where trades could take up to two months or more from point of sale to final buyer debit. Ultimately transactions between any two individuals anywhere in the country can be completed instantly.

In the meantime Transaction Recorders handling Intertrades can process them as usual on there own System and then go on line to their own LCNZ account and debit the Buyers account, no more envelopes and stamps and finding the time to post the Transaction cheque to the LCNZ Transaction Recorder. Balances are updated instantly and statements can be checked at any time. Therefore

monthly Statements will no longer be produced.
